SOFTWARE LICENSE AGREEMENT

1. (License Terms)

- (1) FUJIFILM Business Innovation Corp. (hereinafter called the "FUJIFILM BI") grants you a nontransferable, nonexclusive license to use the software programs and the relevant data and materials included in the Print Server (hereinafter called the "Software") on a single computer;
- (2) The license will be valid from the installation of the Software until the occurrence of any of the events specified in Article 8(1).
- (3) For the software produced by the third party that the Software includes, of which the license agreement in addition to the main contract is bundled with this product, or which has the special designation from FUJIFILM BI, the said third party grants you a license according to the license agreement that the said third party designates.

2. (Rights to the Software)

FUJIFILM BI or its original suppliers retain all copyrights and any other intellectual property rights to the Software.

3. (Restrictions)

During the term of the license and even thereafter, you may not:

- (1) Assign, pledge, or hypothecate the Software, in whole or in part, to or for any third party;
- (2) Grant to any third party a sublicense to use the Software, in whole or in part;
- (3) Disassemble, decompile, or otherwise reverse-engineer the Software, in whole or in part;
- (4) Modify, cut, or otherwise adapt the Software, in whole or in part;
- (5) Copy or reproduce the Software, in whole or in part;
- (6) Disclose to a third party any technical information (with the exceptions specified in Article 7) which you obtain with regard to the Software or in connection therewith; or
- (7) Use any computer program incorporating the Software, in whole or in part, at any site other than the user's place of work; or disclose, sell, lease, rent, or sublicense such program to a third party.

4. (WARRANTY LIMITATIONS)

- (1) FUJIFILM BI GRANTS YOU THE LICENSE TO USE THE SOFTWARE ON AN "AS IS" BASIS. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAWS, FUJIFILM BI MAKES NO WARRANTY, EXPRESS, IMPLIED, OR STATUTORY, WITH RESPECT TO THE SOFTWARE, NOR DOES FUJIFILM BI WARRANT THAT THE SOFTWARE IS APPROPRIATE, USEFUL, OR FIT FOR A PARTICULAR PURPOSE; THAT THE SOFTWARE WILL OPERATE WITHOUT INTERRUPTION OR ERROR; OR THAT ALL FEATURES OF THE SOFTWARE WILL FUNCTION CORRECTLY WHEN USED IN YOUR SPECIFIC SOFTWARE ENVIRONMENT.
- (2) TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAWS, IN NO EVENT WILL FUJIFILM BI BE LIABLE FOR ANY DAMAGES CAUSED TO YOU BY USE OF THIS SOFTWARE, INCLUDING, BUT NOT LIMITED TO, LOSS OF PROFITS ARISING FROM SOFTWARE MALFUNCTION OR MISOPERATION, DAMAGES ARISING UNDER SPECIAL CIRCUMSTANCES, LOSS OF DATA, OR THE INSTITUTION OF ACTION FOR DAMAGES OR INJUNCTION TO SUSPEND USE OF THE SOFTWARE BY A THIRD PARTY AGAINST YOU IN CONNECTION WITH INTELLECTUAL PROPERTY RIGHTS.

5. (Data Backups)

You are responsible at all times and at your own expense to take appropriate measures to protect computer programs and data developed using the Software.

6. (Export Restriction)

In the event that Customer wishes to export the Software, Customer shall comply with the Foreign Exchange and Foreign Trade Law of Japan, the Export Control regulations of the United States, and any applicable laws of the respective regions. If necessary, Customer shall obtain the appropriate license for re-export from the authorities concerned.

7. (Confidentiality)

You acknowledge and agree that any information provided by FUJIFILM BI hereunder (including, but not limited to, the technical content of the Software) constitutes confidential information belonging to FUJIFILM BI and its original suppliers; and that you will not use, disclose, or reproduce such confidential information, in whole or in part, in any manner not specified herein, or for any purpose other than the purpose specified herein, without obtaining prior written consent from FUJIFILM BI; provided, however, that the following information will be excluded from the scope of confidential information:

- (1) Information that you can prove was lawfully known to you before being provided by FUJIFILM BI;
- (2) Information that is or enters the public domain through publication or otherwise and through no fault on your part; or
- (3) Information that you can prove to have developed independently.

8. (Termination of License)

- (1) This license to use the Software will automatically terminate if:
 - (1) You violate any provision of this Agreement; or
 - (2) You obtain a license to use any other version of the Software.
- (2) Upon termination of the license to use the Software, Customer shall immediately delete or destroy the Software.

9. (Governing law and Jurisdiction)

This Agreement shall be governed by and construed in accordance with the laws of Japan. Any dispute arising out of or in connection with this Agreement shall be subject to the first and exclusive jurisdiction of Tokyo District Court. To the extent that applicable local law prevents certain disputes from being resolved in Tokyo District Court, then you can file those disputes in your local courts. Likewise, if applicable local law prevents your local court from applying Japan law to resolve these disputes, then these disputes will be governed by the applicable local laws of your country, state, or other place of residence.
